#### Event HQ.

St Nicholas at Wade C of E Primary School, Down Barton Road, St Nicholas-At-Wade, Birchington, CT7 0PY.

**Directions to start from HQ:** Turn left from the HQ and then turn right into The Street. After approximately 100 metres, turn right into Manor Road. At the crossroads at the end of Manor Road, turn right onto the A28 to the start, approximately 500 metres from crossroads.

## Course Details – Q25/10

<u>Start</u> at public bridle way sign on A28, approx 400yards SW of St. Nicholas at Wade sign (TR 264658). Continue along A28 to St. Nicholas RAB turn left onto Thanet Way westbound. Continue to Broomfield interchange, turn left and over bridge to rejoin Thanet Way eastbound.

Continue to St. Nicholas RAB where turn left into Potten Street Road. Continue west along Potten Street Road, taking 2<sup>nd</sup> left turning over the bridge (**Riders are warned to take special care at this junction as you must not cross the white line)** (SP St. Nicholas) and take the first left into Wantsum Way to rejoin Thanet Way westbound.

Proceed as on 1<sup>st</sup> circuit to return to St. Nicholas RAB turning left into Potten Street Road as above. Continue west along Potten Street Road, taking 2<sup>nd</sup> left turning over the bridge (SP St. Nicholas) and take the 1<sup>st</sup> left into Wantsum Way to <u>finish</u> at centre of 2<sup>nd</sup> drain past the entrance to St. Nicholas Court Farms (TR 262671).

## **Competitors Notes**

**Covid-19 CV19 is still very much present and the CTT still have some guidance in place as follows:-.** Competitors should not attend if they feel ill in ANY way especially if they or family members have any CV19 symptoms.

An elevated resting heart rate or exceptionally quick to react heart rate during warm up can suggest an underlying asymptomatic illness of ANY kind, and that they should DNS and leave immediately and not go to the start line if they feel this is the case.

Any competitor where the above is relevant should obtain a lateral flow test.

Competitors are encouraged to undertake a lateral flow test prior to attending the event.

Any Positive Tests - the competitor should not attend the event.

Spectators and officials are encouraged to undertake a lateral flow test before attending the event.

1..Competitors must make themselves aware of any special safety instructions for the event and sign the official signing-on sheet when collecting their number.

2. In the interest of safety, you must wear recognised protective headgear that meets an internationally accepted safety standard. CTT Regulations state that **ALL** riders **MUST** wear such headgear.

3. A WORKING front and rear light, either flashing or constant, MUST be fitted to the machine at the start of the event.

4. Parking is not permitted within 25 metres of the start or at the finish.

5. Riders must not warm up on the course after the start.

6. It would be appreciated if riders do not wear shoe plates in the HQ.

7. Numbers should be centrally positioned below the waist so as to be clearly visible from the rear.

8. Riders who use an inhaler for medical reasons (asthma etc.) should register the fact with British Cycling to satisfy UCI, CTT and BC anti-doping regulations.

9. Whilst competing riders must ensure they adhere to the Highway Regulations and CTT Rules and Regulations, disciplinary action may result from any breaches in these regulations.

10. Riders are required to sign on before collecting their number at the HQ. Please bring your own pen.

11. Please ensure that you pin your number on your lower back as per CTT Regulation number 16. If you pin it too high on your back, the timekeeper may miss it and you could be shown as DNF on the result sheet

12. Please keep the noise to a minimum to avoid unnecessary disturbance to the local residents.

13. Riders risk disqualification if they perform U turns in the start and finish areas or use these areas as a public toilet. Please be aware that traffic approaching the start area from Sarre may be moving fast.

14. Due to the layout of the course, you will pass the timekeeper twice.

15. On passing the finish timekeeper, you will need to stop <u>before</u> rejoining the Thanet Way and turn round in order to return to the HQ. **Please take extreme care when doing this as there may be other riders still competing and other road users to be considered**. To return to the HQ, return past the timekeeper, turn left at the T junction and then right into Down Barton Road after 200 metres.
